<u>Subsurface Onsite Wastewater System Design (PE Board)</u> – There was discussion about a memo that was put out by the PE Board that listed onsite wastewater systems that needed to be designed by a PE (ie. The design constituted Engineering). It was noted that this was simply a memo, not a law or rule and included more systems than the current onsite wastewater rules.

Soil Scientists Seal Requirements – An individual emailed the NCBLSS about a report he had received. He was asking the board for help to understand if a report he had received constitutes the practice of soil science, was it a professional opinion, and should it have been sealed. And as a corollary, he asked for help understanding 89F-3 (4) what constitutes the practice of soils science and when a seal is required. Discussed was had on what is required. It was decided no seal is required for preliminary reports. Walter Giese said he would draft a reply and send it to Anne Brown for review.
