## **Meeting Minutes:**

Reading of the Ethics Statement by Chairman Hall.

Drs. Josh Heitman, Mike Vepraskas, and Aziz Amoozegar presented a proposal for a procedure by which professors may be licensed as Soil Scientists by the Board.
